Judging Criteria:

The judging committee, consisting of credit union professionals will score each applicant on the following criteria:

- 1. High school performance
- 2. Outside of classroom activities
- 3. Letters of Recommendation
- 4. Career goals
- 5. Professional presentation

Application Deadline:

Applications must be postmarked by Monday, March 31, 2025. Applications should be sent to the following address:

Scholarships:

Northern Hills Federal Credit Union will award three scholarships in the amounts of \$1000, \$750, and \$500 for applicants that exemplify the credit union philosophy of "people helping people" through volunteering, community service, and leadership. The scholarships will be awarded for the 2025-2026 school year. The proceeds will be mailed directly to the financial aid office at the school shown on the application upon receiving verification of enrollment from the scholarship recipient.

Eligibility Requirements:

- ☐ The applicant <u>must</u> be a member in good standing of Northern Hills Federal Credit Union
- ☐ The applicant must be a graduating high school senior.
- ☐ The applicant must be attending an accredited college, university, or vocational/technical school.

Application Requirements:

- ☐ A completed copy of the application form.
- □ A copy of your cumulative grade transcripts.
- □ A list of outside of classroom activities and years of participation.
- ☐ Two written letters of recommendation from your teacher, guidance counselor, supervisor, or community leader.
- A three-part essay describing
 - How your high school classes have helped you prepare for postsecondary education.
 - How your out of classroom experiences exemplify the credit union philosophy of "people helping people."
 - Your career goals.

Essay should be, typed, double-spaced on plain white paper.

Be sure to make a copy of the complete package for your records.
